Scope of the warranty:

- The manufacturer grants warranty to the buyer for the period of 24 months from the date of the purchase.
- 2. In order to be eligible for warranty benefits, a warranty card and proof of purchase are required (the document can be downloaded at www.perfectdoor.pl).
- 3. The warranty applies to all products manufactured and sold by the PerfectDoor company.
- **4.** The warranty only covers the physical defects of the product itself, hidden and not visible at the time of purchase, and revealed during the warranty period.
- 5. The manufacturer bears the costs of delivering the product to a **retail outlet**.
- 6. The guarantor decides within the period of 14 days on the manner in which the warranty is to be dealt with.
- 7. The warranty does not limit buyer's rights arising from the nonconformity of sales contract.
- 8. Our products are based on the data contained in the Technical Approval number AT-15-7673/2015, which allows the following defects of flatness:

MEASURMENTS

Deviations in the measurements of rebate clearance should be in accordance with ZUAT-15/III.16/2007 and be maximum + 2 mm - 1 mm

Deviations in the measurements of door leafs should not exceed the range of deviations allowed for tolerance class 2 according to PN-EN 1529:2001, which means +/- 1.5 mm (deviations in width and height) and +/- 1mm (deviations in thickness).

Deviations from the nominal values in the measurements of wooden door frames should not exceed the range of deviations specified in ZUAT-15/III.16/2007, which means outer width and height +/- 5 mm, opening dimensions up to 1m +/- 2 mm, above 1m +/- 3 mm, section thickness +/- 1 mm, section width +/- 2 mm

LEAF SQUARENESS

Deviations from leaf corner squareness should not exceed deviations allowed for tolerance class 2 according to PN-EN 1529:2001, which means 1.5 mm

LEAF FLATNESS

Deviations from leaf corner squareness should not exceed deviations allowed for tolerance class 3 according to PN-EN 1530:2001, which means: corner flatness deviation should not exceed 4 mm, longitudinal bend (towards height) should not exceed 4 mm, transverse bend (towards width) should not exceed 2 mm.

Warranty conditions:

- 1. All defects should be reported in writing to the **point of purchase**.
- 2. Photo documentation constitutes the grounds for examining the complaint. The documentation has to include:
 - a. Photo of the packaging.
 - b. Photo of the whole product.
 - c. Photo precisely depicting the object of the complaint.
 - Photos of labels and control stamps placed on the product and packaging in places described in the manual.
 - e. In case of deviations of dimensions or holes, filled measurement card available at www.perfectdoor.pl.

- Apparent defects (in particular nonconformity of the product with the contract and external
 mechanical damages) must be reported immediately during the receipt of the goods at the
 point of purchase.
- **4.** Apparent defect is a defect, which fulfils all of the following:
 - a. Is visible from not less than 1.5 m.
 - b. Is visible with naked eye under diffuse daylight conditions.

Other defects should be reported within 7 days from the date of purchase, but before installation.

- 5. In case of disclosure of defects due to transportation, damages protocol should be written down and should be attached to the complaint documentation.
- **6.** Hidden defects should be reported within 14 days after being revealed.
- Installation should be done according to good engineering practices and assembly instruction available at the manufacturer's website.
- **8.** The warranty ceases to be valid:
 - a. when structural changes not in accordance with assembly instructions are made;
 - b. when fittings are placed in case of hidden defects;
 - c. due to inappropriate transportation or storage;
 - d. due to inappropriate protection against external condition, including moisture and UV:
 - e. due to inappropriate assembly or utilization;
 - f. due to defects caused by negligence of the buyer.

Warning!

Permitted changes in design without the loss of warranty include shortening of door

leaf by 30 mm at most.

- **9.** The warranty does not cover:
 - Damages to the coating due to inappropriate conservation, cleaning or use of inappropriate protective tapes.
 - b. Damages due to normal wear and tear.
 - c. Differences in shades (for example decorative grooves) due to imitation of natural structure of wood or due to production technologies.
 - d. Spot discolorations due to manufacturing processes.
 - e. Damages of elements due to swelling of the material caused by moisture.
 - f. Products other than first sort.
 - g. Damages due to fortuitous event or natural disaster.
- **10.** Maximum cost of defect removal is limited to the value of product at purchase.
- 11. Defect removal takes place within 60 days from the acceptance of the claim. The time limit is extended as a result of buyer's fault, periodic production breaks, holiday breaks or disruptions beyond the control of the guarantor. The buyer will be notified of the causes immediately after their occurrence.
